ECHE HOLDERS

In Republic of North Macedonia there are 25 accredited HEIs, out of which 5 are state/public universities and 20 are private HEIs. All state universities hold valid ECHE charter for the whole duration of Erasmus+, while interest for applying at private HEIs for ECHE charter is increasing each year.

Number of ECHE holders is increasing every year, also number of applicants/HEIs in the Erasmus+ programme also increasing, 11 applicants in 2013, 12 applicants in 2014, 15 applicants in 2016, 18 applicants in 2017 and 23 applicants in 2018.







 Trends of increasing of approved student mobilities for studies, student traineeships, staff teaching assignments and staff trainings is obvious regarding promotional activities at all HEIs in our country.

 In relation to the initial year of 2014, the increased number of student mobilities for studies and student placements/traineeships is obvious in accordance with requested, approved and realized mobilities. The number of Universities which received ECHE for the Erasmus+ programme is increasing. This demonstrates clear intention of the HEIs for involvement into EU mobility programs.

 At the end of 2018, 24 out of 25 HEIs are holders on valid Erasmus charter






Geographical spread


Balanced geographical representation that covers all geographical regions in the country




At the survey carried out by the National Agency regarding influence of the Erasmus+ mobility, participated student from the biggest higher education institutions.

Most of the students who answered the questionnaire were from Faculties of Medicine, Economics, IT and Mechanics, and 81% of them were on mobility during bachelor studies and 19% during their master studies (Masters Degree).






Regarding the ECTS, students confirm that all credits obtained are recognized by the home university in accordance with the curriculum. There are exceptions where for an subject during mobility, the student received 8 credits, and only 6 are recognized in the home university, because such credits carry this subject at the home University



81% of students would participate again in the MOBILITIES/TRAINEESHIPS within ERASMUS + program and 100%, recommend the program for other students.



Language competences

72% of students were on mobility for one semester, while the rest 28%, used the mobility for 2 semesters.

Nearly all, 98% of the respondents claim that for the period of mobility they improved language competences in English and the official language of the country where they were on mobility or traineeship.
